Pension Schemes for your paid staff

In October 2012, a new statutory obligation was placed on all employers to have a qualifying pension scheme, and to auto-enrol eligible workers. This duty is being progressively rolled out, and now small employers with less than 30 workers will have to start enrolling their workers from around April 2016.

This is NOT OPTIONAL - all employers will have to offer something. Both employer and worker will have to make compulsory financial contributions into the scheme.

Lloyds Bank Foundation report finds that obtaining funding is the biggest challenge for most small and medium sized charities

The report is based on a survey of 800 charities that are working in social welfare which explored the challenges they face and what would help overcome them. The main challenge for 81% of the respondents is securing funding for their organisation, while 63% think it will get harder to secure funding over the next two years.

Funding for Research and Projects that Address Learning Disabilities

Baily Thomas Charitable Fund is currently accepting applications. The Trust funds research and projects around severe learning difficulties and autism. They consider projects concerning children or adults.

The types of activities currently funded include:

- Capital works for residential, nursing and respite care, and schools
- Employment schemes including woodwork, crafts, printing and horticulture
- Play schemes and play therapy schemes
- Day and social activities centres including building costs and running costs
- Support for families, including respite schemes
- Independent living schemes
- Support in the community schemes
- Snoezelen rooms.

Applications will only be considered from voluntary organisations which are registered charities or are associated with a registered charity. Schools and Parent Teacher Associations and Industrial & Provident Societies can also apply. Funding in the past has ranged in value from £250 to £150,000.

Heritage Lottery Fund - Funding to Regenerate Public Parks and Gardens

Deadline is **29 February 2016**. Provides grants of between £100,000 and £5 million to Local Authorities as well as not for profit organisations that own public parks and gardens to regenerate public parks of national, regional or local heritage value. To be eligible applicants will need to show that:

- The community values the park as part of their heritage

- The parks meets local social, economic and environmental needs
- The park management actively involves local people.
