# New project: Victims' Voice

Victims' Voice has been set up by Disability First and Smile Mediation coming together to support any victim of hate crime. The project is funded by the Police Crime Commissioner and their main aim to provide support, advice and advocacy to any victim of any strand of hate crime across Lancashire.

A hate crime is any crime or incident which targets people because of their/or their perceived:

- Race
- Religion
- Disability
- Sexual Orientation
- Gender Identity

And even though sub-culture is not monitored by Lancashire Police they both still want to support victims of hate crimes in this area.

They have 3 dedicated caseworkers who can work with victims on a one-one basis providing individualised support which can help them overcome their victimisation. They are able to offer advice and guidance and they have a network of services they can signpost people onto to access the support they need.

They are also able to offer free awareness training in schools, colleges, organisations and work places in hate crime and bullying through the outreach worker.

#### Don't forget your Christmas prescriptions

With Christmas fast approaching, people with long-term health conditions such as asthma, diabetes, lung and heart disease are being reminded not to leave it too late to get their repeat prescriptions but to only order what they need.

Many GP surgeries will be closed on the bank holidays over Christmas and New Year, so it is wise for people to think about the medication they will need before the festive period begins.

The local NHS CCGs in Southport, Formby and West Lancashire are also reminding people to examine their options and that A&E and 999 services are for life-threatening and serious conditions.

#### Feeling Unwell? - Examine Your Options

Across the area there are a range of health services to support people if they feel unwell or have any health concerns. There are services which you may be unfamiliar with, but could be more appropriate and convenient for you depending on your specific issue.

For minor ailments and injuries your best route to recover is likely to be self-care. There are a variety of services that can support you to do this:

#### **Pharmacy Services**

Your local pharmacy can offer free, confidential and expert advice on a range of health issues.

They can help you prepare for many of the common illnesses like coughs and colds and ensure you have a well-stocked medicine cabinet over the holiday period.

### NHS.UK

You can find a wealth of trusted advice about hundreds of health conditions and details of GPs, pharmacies and dentists in your local area by visiting the NHS.uk website: <u>www.nhs.uk</u>. It also includes a symptom checker.

#### NHS 111

When you need medical help or advice fast, but it is not a 999 emergency, you can also call the NHS 111 service. NHS 111 is available 24 hours a day, 365 days a year and calls are free from mobiles and landlines.

If you need medical care for illnesses you cannot treat yourself, then your GP should be your next port of call.

#### Your Local GP

Your GP should be your first point of contact for non-emergency illnesses you can't treat yourself. Your GP is available from 8.00am to 6.30pm weekdays.

If you don't have a GP, you can register with your local surgery. If you're not sure where this is, you can find out at: <u>www.nhs.uk</u> or call 0300 77 77 007.

#### **GP Out of Hours Service**

If your local surgery is closed, you can still see a GP with the GP out-of-hours service; just call 111 and you can speak to a local GP over the phone or face to face if necessary.

It is very likely that you and your family will be seen and treated more quickly using the out-ofhours service than if you were waiting to see a doctor in A&E, especially at busy times.

#### **NHS Walk-In Centres**

Walk-in centres provide treatment 365 days a year for illnesses that you can't treat yourself and there's no need to book an appointment.

Yet for the <u>25% of charities with grants</u> <u>or contracts from government</u> – particularly those due to end next March – there was little by way of relief. # Lancashire Commissioner Offers New Grants for Crime Fighting Schemes across the County

Lancashire's Police and Crime Commissioner, Clive Grunshaw has announced a new wave of grants aimed at delivering his police and crime priorities across the county.

Grants of between £5,000 and £100k are available to help organisations establish new initiatives that will help to make Lancashire safer through:

- supporting frontline policing
- protecting vulnerable people
- tackling crime and re-offending or
- championing victims' rights.

The cash grants will be funded from money seized through the Proceeds of Crime Act. In Lancashire over the last few years, £1.2m has been returned to the Police and Crime Commissioner following court action to take funds and assets from convicted criminals.

The fund is open to all sectors working to deliver services or schemes in line with the police and crime plan and applications can be made either as individual organisations or as partnership bids.

The money cannot be used to fund existing revenue costs, but can be used to set up new schemes or for capital investment to help a service improve or grow.

Grant applications must be supported by a business case and meet the funding criteria.

All non-capital grant funding must be match funded and must show evidence that a scheme can become self-financing or sustainable in the future.

Applicants have until **18 December 2015** to submit their grant submissions.

# **Funding for Community Youth Projects**

# Lloyds Bank Foundation Announces Next Funding Round

Grants programmes will re-open for enquires on the 4th January 2016. The Foundations operates two funding programmes. These are:
